

"COVERED BRIDGE REMEMBERS..."

THE LIBRARY

Probably the most dramatic change from its beginning was our Library. Originally it shared space with a washing machine (not sure about the dryer) because the double-wide homes had no space for washing machines.

The current library area shared space with the following:

- 1. <u>CB Office</u> was located in the far corner (cramped), with a dividing wall and consisted of 1 desk, 2 chairs, copying machine and filing cabinet. You had to open door carefully so as not to bump into anyone.
- 2. **Pool Table** was centered in the available space, limiting players to make cramped shots because of the limited space.
- 3. Phone Books lined the walls around the pool table, stacked two and half feet high only (so as to not block the pool shots). They were important 20+ years ago and the HOA community held an annual dumpster diving event to find extra books for their contribution to the Early Recycling Movement Contest. Covered Bridge usually won 1st prize (\$300), and used the money for a CB Bar-B-Que.
- 4. <u>Book Shelves</u> took the remaining cramped space, made by our own CB carpenters.

This is what we remember! HELP!

HOA BOARD MEETING FEBRUARY 15, 2022

The February Meeting of the Board of Directors of the Covered Bridge Association, Lake Placid, Florida met in the Clubhouse. Tuesday the 15th of the month, with 58 people present. There were no new President Tom residents to introduce. Taylor called the meeting to order at 10:06 a.m., welcoming the board members, residents and guests. After reciting the Pledge of Allegiance and observing a moment of silence it was noted that there were five of seven board members present, with Leigh Russ and Cindy Hubbel being absent from the meeting.

Secretary Rick Kennedy read the minutes of the Dec 21, 2021 Covered Bridge Board Meeting, as there was no board meeting held in January. With a minor addition and a correction, the minutes were approved as corrected.

In the absence of Treasurer Leigh Russ, Cliff Hangley presented the December Financial Report, stating that all bills were paid, deposits made and everything was up to date. He also gave a brief explanation as to how adjustments were being made in regard to **overpayments of the 2022 HOA** monthly payments made prior to the March 1st effective date.

During the President's comments, Tom Taylor mentioned the need for residents to **tighten up the control of their dogs**, particularly with the barking and cleaning up. He thanked volunteers for the amazing amount of work accomplished during work days and stressed the need to get new residents involved in volunteering to take care of our lovely community.

Under Old Business, Jack Gaisor discussed the repairs and improvements needed on the **shuffle board court**, especially the need for increased shade. Tom Taylor explained the committees proposed expansion of the roof over the court. After much discussion, it was moved by Patty Hynes and seconded by Cliff Hangley to proceed with the improvements. The motion carried after a vote.

Tom Taylor explained a proposal submitted for a **Dog Park** for the community. This included a 60 x 100 ft fenced area across and north from the bridge, with two gates. The quote from Delaney Fence Company was \$6,311.00. Tom explained the committee would try to get two more quotes and that the board wanted to hear much more from the community on this matter. Several residents responded with discussion both the pros and cons.

RV/Boat Storage was the next topic. Tom explained that our attorney said the \$10.00/month fee was a legal charge for someone using a second space. Our rules need to be updated to explain that there is not a guaranteed space for everyone. The board needs to vote at the next meeting on a change of the wording.

Tom Taylor explained the needed updates to the Architectural Committee Rules, including **home color choices** and the requirement of building permits for all exterior construction. Ron Cobert discussed the use of color charts and letting residents select the paint source of their choice.

Comments by resident Jim Stanton included reviewing a **long sitting trailer** in the RV/Boat Storage and also suggested that the Architectural Committee approve house color choices individually, rather than try to limit the choices.

On **road repairs**, Cliff Hangley talked about the repairs on Venetian Parkway, stating that it would consist of rebuilding small sections rather than a "band-aid" style short term repair.

In New Business, Tom Taylor explained the name change for the "Cottage Company" and relayed they are currently building 12 new homes in Covered Bridge, which is causing excessive **heavy truck traffic**. Tom stated there seems to be notable progress in getting

the builder, Ken LeBlanc, to repair the damage that's been occurring.

Ron Cobert mentioned during the committee reports that the Architectural Committee has had **20 requests** which were all approved.

<u>**Bill Burse**</u>, reporting for the RV/Boat Storage committee, stating "if you don't use your space, you will **lose your space**".

<u>**Donna Palmetier**</u> discussed setup procedures, timeline of **events and meals** for workers during the upcoming Fair.

Bobbi Snow informed the group about upcoming **entertainment and activities**, including a comedy show on Feb 26th, a Fish Fry on Feb 25th, Movie Night on Feb 20th and a Corn Hole Tournament on Feb 23rd.

<u>Patty Hynes</u> told us about the "Celebration of Life" for this year.

<u>Claire Leffler</u> talked about purchasing tickets for the prizes to be given away at the Fair, and also the need for everyone to turn in their "Fair Passes" after the Fair. Then afterwards the group sang "Happy Birthday" to Claire.

Ron Cobert mentioned that we are getting lots of annoying odors from the water/sewage area. Tom Taylor encouraged residents who are being affected, to call and register a complaint with the water company.

With no further business to transact, Cliff Hangley made a motion to adjourn and Bill Burse seconded the motion. The motion passed and the meeting was adjourned at 11:22 a.m.

HOW TO FIND THE RIGHT LAWYER

If your legal problem is complex or involves lots of money, you may not want to attempt to handle the entire matter without a lawyer. After all, lawyers do more than dispense legal information. They offer strategic advice and apply sophisticated technical skills to legal problems. Locating a good lawyer who can efficiently help with your particular problem may not be easy. Don't expect to locate a good lawyer by simply looking in the phone book or reading advertisement. There's not enough information in these sources to help you make a valid judgment.

A better approach is to talk to people in your community who have experienced the same problem you face. If you talk to half a dozen people who have had a similar problem, chances are you'll come away with several good leads. Don't, however, make a decision about a lawyer solely on the basis of someone else's recommendation. Different people will have different responses to a lawyer's style and personality. Don't make up your mind about hiring a lawyer until you've met the lawyer, discussed your case and decided that you feel comfortable working with him or her.

Many sites offer a way to connect with local lawyers based on your location and the type of legal case you have. You answer a few questions about your case and give your contact information, than the right type of lawyers will contact you directly. Businesses who provide services to individuals in the legal area that you are interested in, may also be able to assist you in finding the right lawyer. For example, if you are interested in small business law, speak to your banker, accountant, insurance agent and real estate broker. These people come into frequent contact with lawyers who represent business clients.

Lawyers' referral service is another good source of information. There is a wide variation in the quality of lawyer referral services, however, some lawyer referral services carefully screen the attorneys and list only those with particular qualifications and past experience. Here are other sources you can turn to for possible candidates. The director of your local chamber of commerce; a law librarian can help identify in your town who have written books or articles on

a particular subject; a women's or men's support group will probably have a list of well regarded family and divorce lawyers.

Most lawyers specialize in certain areas, and even so-called "general practitioner" may not know that much about the particular area of your concern. It can pay to work with a lawyer who already knows the field and is already far up the learning curve. The next step is to talk to each lawyer personally.

Pay attention to the personal chemistry between you and your lawyer. If you feel uncomfortable with that lawyer, you may never achieve an attorney-client relationship.

When you have a legal problem, you need legal information. Lawyers, of course, are prime sources of this information, but if you bought all the needed information at the lawyer's rate an hour, you will quickly empty your bank account. Fortunately, many lawyers will work with you to help acquire a good working knowledge of the legal principles and procedures you will need to deal with your problem at least partly on your own. If you are hoping to represent yourself and use a lawver only for advice, make sure the lawyer is open to that type of set-up. Likewise, if you're going into business and will draft your own bylaws or business agreements, ask the lawyer if she or he is open to reviewing your drafts and making comments.
