<u>COVRED BRIDGE BOARD OF</u> DIRECTORS HOA RULES UPDATE

As many residents know, the BOD is challenged with Covenants that are dated and have had selective enforcement for several years. The authors of the Covenants understood that changes and exceptions would be needed. So, they included language to select parts of the Covenants that allowed the board of directors to give written approval for exceptions to the covenants. We give that written approval sparingly through our rule's documents.

The goal of the current board has been to update rules with the best interest of the community while respecting the covenants and homeowners' rights. We do not take rule changes lightly; we get community input along the way and always do so under legal counsel to ensure we are not acting beyond our authority or creating rules we cannot legally enforce.

A simple drive around our community provides clear evidence of our lack of enforcement over the past decade or more. Legally, we have set a precedence and cannot change it back, despite what some of our local sea lawyers would like us to believe. We can enter costly court battle with our residents and waste thousands of dollars with the result being a court ordered approval of the violation and conflict/division within the community.

In May of this year, the board approved and implemented a legal change to our Architectural Committee Rules document to resolve an issue with a resident who worked with Cottage Company to design and build a home with an above ground propane tank, with our approval. It is clearly noted on the original plans for the home on file in our office. Not knowing that an above ground propane tank was not allowed they lived in the home for over 7 years. In October of 2021 a member of the architectural committee noticed the tank and took exception to the tank and started a campaign to get it removed.

After investigation and consultation with our legal counsel we determined that the rule was

due to aesthetics, and we could resolve the issue by allowing smaller tanks that are not visible from the road. This will also resolve the issue with several other small propane tanks on BBQ Grills or water system tanks as the rule only states "tanks" not "propane tanks" it will bring the brine and resin tanks used for water treatment systems into compliance.

This recent change has angered a few residents who do not support the change and are protesting the change. While the board welcomes differing opinions, we do not support the spreading of misinformation or scare tactics to sway community opinion.

Propane tanks installations are designed and installed by licensed professionals who following NFPA 58 LP Gas Codes, like the National Electric Code for electric services but for gas. They are on millions of homes across the country, are not prone to explosions and are anchored by the strong copper or rubber service line that prevent them from becoming a projectile during a storm. One of our board members is a past President of the American Gas Association's Safety and Occupational Health Committee and has been called upon to testify in congress and the judicial system in response to Gas Safety issues. He also assures us that this is not a safety issue but misinformation.

The purpose of this article is to present the boards position, the dissatisfaction of those opposed to the rule change and solicit input from the community. Our final decision needs to be legal as we cannot break the law or infringe on someone rights, but we are always anxious to hear differing opinions.

If you have an opinion, in support of either point of view, please let us know. As noted above, we believe our options are limited. The rule has been implemented so the request to "delay" implementation is not an option at this point. So, if you have any great ideas, we would love to hear them either in person, in writing or at our residents meeting in January. Stay safe, stay happy!
